ORDER

1. The President, Kerala State Self Financing Pharmacy College Management Association (KSSPCMA), representing 37 member colleges has submitted the draft prospectus in respect of B.Pharm-M.Pharm-Pharm D-Pharm D PB- Pharmacy courses for the academic year 2020-21 before the Admission Supervisory Committee, herein after referred as the committee, for approval.
2. The committee scrutinised the draft prospectus submitted by the President, KSSPCMA, and provisionally approved the same subject to the certain observation and directions:-

- i.** The Principal of the Pharmacy College come under the KSSPCMA is hereby directed to produce the continuation of provisional affiliation order and Minority certificates if any, obtained from the Competent Authorities at the earliest.
- ii.** The application shall be invited by the Association only through online. No other mode of inviting application shall be entertained and liable to be rejected.
- iii.** The online application should contain the following information:-
 - The online application form should contain Auto generated Registration/ Application Number and auto generate date and time of submission of application.
 - The facility for uploading the photograph and signature of the candidate shall be provided.
 - The category/quota shall be clearly specified in the online application form.
 - The declaration of the candidate, as to the details provided in the application are true to the best of knowledge, should be included in the online application form.
 - After the submission of the application, the candidate should generate a PDF format which should include the name and address of the selected member college. The KSSPCMA shall provide the facility, as above.
 - The facility for taking print out of the application shall be provided to the candidate by the KSSPCMA.

The President of the KSSPCMA shall ensure that the aforesaid information is included in the online application form.

- iv.** The President of the KSSPCMA is hereby directed to submit the draft notification for inviting online application before the committee **on or before 27.07.2020**, for approval. The approved notification shall only be published in the dailies and the electronic media.
- v.** The member Pharmacy colleges come under the KSSPCMA are shall not be entitled to retain the 1st year or other fee, if the student discontinues the course before the last date of closing of admission, prescribed by the competent authorities.
- vi.** The collection of liquidated damages shall be as per the final decision of the ASC/Court of Law. The colleges have no right to retain the Certificate and TC in case of student leaving the college, and the same shall be released, on the student with one of his/her Parents executing a bond undertaking to pay the amount that may be ordered by the Committee or the Court of Law.
- vii.** The President of KSSPCMA is hereby directed to obtain prior approval from the committee at every stage of admission procedure.
- viii.** The Minority certificates in respect of the Community/Minority Quota category students shall be obtained from the revenue authorities as per the directions contained in the Hon'ble High court and apex court orders.
- ix.** The tentative time schedule mentioned in the draft prospectus shall be modified and approved as follows:-

- xi.** The Member of the Pharmacy colleges come under the KSSPCMA shall strictly follow the directives issued by the Committee dated 10.05.2019 & 22.01.2020.
- xii.** The Pharmacy colleges shall collect only the fee fixed for Pharmacy courses by the Committee during the academic year 2019-20, considering the wake of the spread of COVID-19 and present socio-economic condition.
- xiii.** The Pharmacy Colleges shall make aware of the candidates about the other fee and hostel fee details at the time of admission. This is necessary to avoid future litigations and complaints.
- 4.** The President of KSSPCMA, is also hereby directed to submit the modified prospectus before the committee after making the above corrections at the earliest. The modified prospectus alone shall be uploaded in the Association/College website.
- 5.** E-mail this order to the President, KSSPCMA. The President of the Association shall communicate the approval order and the directions/observations to the member pharmacy colleges.
