ORDER

University had invited application from it's affiliated colleges in connection with granting Continuation of Provisional Affiliation for the academic year 2026-27, vide paper read (1) .

2. Accordingly, 2 Pharmacy Colleges mentioned in the table below had submitted application for Continuation of Provisional Affiliation for the academic year 2026-27. These applications were processed by the University and an inspection was conducted in the colleges.

3. The Scrutiny Committee, after scrutinizing the inspection reports and finding no deficiencies, recommended to grant Continuation of Provisional Affiliation to the pharmacy courses with the intake mentioned against each in the 2 pharmacy colleges for the academic year 2026-27 as detailed below :

In the circumstances, considering the fact that the allotment process of the pharmacy courses for the academic year 2026-27 is about to commence soon, sanction is hereby accorded to grant Continuation of Provisional Affiliation to the 2 pharmacy colleges mentioned in the above table for conducting the courses with intake mentioned against each for the academic year 2026-27, subject to the approval from the Pharmacy Council of India and the ratification by the Governing Council.

The Colleges shall strictly adhere to the following conditions:

- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii) Affiliation granted is strictly provisional and only for the academic year 2026-27. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- iv) Admission to the next academic year shall be made only after obtaining prior permission from the University.
- v) The colleges has to remit annual administration fee fixed for UG/PG Courses for the academic year 2026-27.
- vi) The colleges should submit approval order from Pharmacy Council of India for the academic year 2026- 27 before the commencement of classes.
