ORDER

University had invited applications from various colleges in connection with granting Continuation of Provisional Affiliation for the academic year 2025-26, vide paper (1) read.

- 2. Accordingly, 28 Pharmacy Colleges submitted application for Continuation of Provisional Affiliation for the academic year 2025-26. These applications were processed by the University and an inspection was conducted in the colleges.
- 3. The Scrutiny Committee, after scrutinizing the inspection reports, recommended to grant Continuation of Provisional Affiliation to the pharmacy courses in the 28 pharmacy colleges for the academic year 2025-26 as detailed below:

- 4. All the above mentioned colleges have paid the requisite GST arrear amount for the application fee for Continuation of Provisional affiliation for the academic year 2025-26.
- 5. The 84th Governing Council meeting, vide paper (2) read, resolved to grant Continuation of Provisional affiliation to the courses in the 28 Pharmacy Colleges listed in the above table for the academic year 2025-26 based on the recommendations of the Scrutiny Committee and subject to the approval of the Pharmacy Council of India.

In the circumstances, sanction is hereby accorded to grant Continuation of Provisional affiliation to 28 Pharmacy Colleges mentioned in the above table, for conducting pharmacy courses with the intake as detailed against each for the academic year 2025-26 based on the recommendations of the Scrutiny Committee and subject to the approval of the Pharmacy Council of India.

The Colleges shall strictly adhere to the following conditions:

- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii) Affiliation granted is strictly provisional and only for the academic year 2025-26. The College has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- iv) Admission to the next academic year shall be made only after obtaining prior permission from the University.
- v) College has to remit annual administration fee fixed for UG/PG Courses during 2025-26.
- vi) The colleges should submit approval order from Pharmacy Council of India for the academic year 2025- 26 before the commencement of classes.
